Reply of Appeal
(अपील का उत्तर)

The questions in the original RTI query pertained to Mr. Harikrishnan Pisharody Gopalakrishnan who is an employee of the institute. All eight questions were directly concerned with the staff member and regarding actions specific and internal to the institute. Section 8.1(e) of the RTI act specifically says "information available to a person in his fiduciary relationship is exempted from disclosure, unless the competent authority is satisfied that the larger public interest warrants the disclosure of such information". Since the institute assumes the responsibility of its employees, the relationship between employer and employee may be treated as fiduciary and the information sought is also an internal matter that is clearly not in the larger public interest. It is for these reasons that the original query was disposed of. The appeal merely asks how the information cannot be provided and is possibly because the appellant is not aware of what the clause 8.1(e) is and what its interpretations are.
