In my RTI application dated 02.04.2024, I had requested the information pertaining to the Junior Superintendent position advertised vide Advt. No. IITPKD/R/NF/01/2023 dated September 19, 2023:

In response to my RTI application, I have received information pertaining to points 1 and 3 only. However, the final answer key of the Level 1 written examination (point 2) has not been provided. The reply was received in a PDF format which did not include the requested final answer key for Level 1.

The information provided is incomplete as the Final Answer Key for Level - 1 was not included in the response. This is a critical part of the information requested and its non-provision impedes my right to complete information under the RTI Act.

As per Section 6 of the RTI Act, every citizen has the right to request information, and the authority has the obligation to provide the requested information unless it falls under the exemptions provided in the Act. There has been no indication that the Final Answer Key for Level - 1 falls under any such exemption.

1. With regard to the query no.1 of the RTI application, DoPT OM No.1/4/2009-IR dated 05.10.2009 may be referred whereby a Guide on the Right to Information Act 2005 was circulated and Para 10 of Part I of the Guide stated that 'only such information can be supplied under the Act which already exists and is held by the public authority or held under the control of the Public Authority'. In this case the only information available with the Public Authority on the subject matter is the relevant recruitment notification which was referenced to the applicant in the initial reply.

2. The query no.2 and 3 from the applicant sought reason/ rationale for disqualification. In this regard, the DoPT OM No.1/7/2009-IR dated 20 May, 2011, may be referred where in it is stated that 'the definition of information cannot include within its fold answers to the question "why" which would be same thing as asking the reason for a justification for a particular thing. The public Information authorities cannot expect to communicate to the citizen the reason why a certain thing was not done or not done in the sense of a justification because the citizen makes a requisition about information. Justifications are matters within the domain of adjudicating authorities and cannot properly be classified as information'. So, query no. 2 and 3 do not fall under the classification of information and hence not answered. This reason for denial of information was clearly stated in the reply to the applicant.

In view of the above, as the reply was suitably furnished in response to the initial RTI, the appeal may be disposed of.

The denial of information under Sections 8(1)(d) and 8(1)(e) of the RTI Act is invalid for the following reasons:

Incorrect Application of Section 8(1)(d)

The date of signing of the MoU does not fall under “commercial confidence, trade secrets, or intellectual property.”

Disclosure of such information does not harm any competitive position of IIT Palakkad, IIT Madras, or any third party

MoUs between public-funded institutions are administrative agreements, and basic details like dates cannot be classified as commercial secrets.

Incorrect Application of Section 8(1)(e)

The signing date of the MoU is not information held in a fiduciary relationship.

Administrative facts, like the date of signing and names of signatories, are matters of public record and do not breach any confidentiality or trust.

Public Interest Clause (Section 8(2)):

There is a larger public interest in disclosing the signing date of the MoU.

The information is critical due to allegations of corruption, misuse of authority, and procedural irregularities involving IIT Madras and IIT Palakkad

The matter has already been reported to the Central Vigilance Commission (CVC) and Loka Yukta, and withholding such details obstructs transparency and accountability in publicly funded institutions.

Violation of Transparency and Public Accountability:

Denial of this information undermines the right to information and goes against the purpose of the RTI Act, which promotes transparency and accountability.

IIT Palakkad and IIT Madras, as public institutions funded by taxpayers, are obligated to disclose administrative details like dates and officials involved to ensure public trust.

Non-Confidential Nature of Information

The signing date of an MoU is a basic administrative detail and cannot reasonably be considered confidential under any exemption of the RTI Act. and **8(1)(e)** of the RTI Act is invalid for the following reasons:

The details of MoUs signed are as below:
